As used in this Agreement, the term "Contribution" shall mean any software, including source code and/or object code, documentation, or modifications to the foregoing, which You concurrently or subsequently make available or submit to ANSHealth in any form. Contributions shall not include any software or documentation which has been explicitly marked to indicate that it is not a contribution to ANSHealth.

2. You hereby grant to ANSHealth, its successors, and assigns, joint ownership in all worldwide common law and statutory rights associated with the copyrights, copyright applications and copyright registrations in Your Contribution, to the extent allowable under applicable local laws and copyright conventions, and agree never to assert against ANSHealth any oral rights therein. You understand that (i) this Agreement may be submitted by ANSHealth to register a copyright in Your Contribution, and (ii) ANSHealth may exercise all rights as a copyright owner of Your Contribution. This Agreement supersedes and replaces all prior copyright assignments for Contributions made by You to ANSHealth and any terms under any version of the GNU General Public License. Neither party has any duty whatsoever to render an accounting to the other party for any use of a Contribution.

3. You hereby grant to ANSHealth and its successors, and assigns and to any party who receives Your Contribution, a perpetual, non-exclusive, worldwide, no-charge, royalty-free, patent license to make, have made, use, sell, offer to sell, import and otherwise transfer Your Contribution, where such license applies only to those patent claims licensable by You that are infringed by Your Contribution alone or by combination of Your Contribution with the work to which such Contributions were submitted. 6. This Agreement shall be governed by the laws of the State of Pennsylvania and applicable U.S. Federal law, without application of choice of law rules.
